    - i. 2021 waiver has been finalized and is on the website. Anyone who signs up will need a new waiver
    - ii. Travis has completed the tax return. Tom P to pay the bill for getting our taxes as soon as it arrives.
  - b. Website (Nick F)
    - i. In the process of pulling data for outstanding payments so we can archive and clear the database.
- 3. Committee Updates (7:20 7:50)
  - a. Finance Committee (Tom P)
    - i. Balance / Summary / Cash Flow
      - 1. Not much has changed since last board meeting
      - 2. Committees will need to submit budgets for 2021
      - 3. We will have a few different credits for fields when we're able to return to play (Liz A to look into Anderson and circle back to Tom Phillips)
    - ii. Kaylor Donation
      - 1. Kaylors are willing to match donations up to a certain amount
      - 2. Liz A is brainstorming ideas for fundraising
  - b. Diversity, Equity, and Inclusion Committee (Izzi B)
    - i. Meeting tomorrow, will share meeting minutes to the board
  - c. Event Sanctioning Committee (Liz A)
    - i. Will pick back up when activity picks back up
  - d. Club Team Committee (Liz A)
    - i. Will pick back up when activity picks back up
  - e. Conduct Committee (Liz A)
    - i. Accepting volunteers and nominations for committee members
    - ii. Goal is to create better communication with our players to uphold our standards

- 4. Director of Operations Update (7:50 8:30)
  - a. 2021 USA Ultimate Organizer & Coaches Convention
    - i. Liz A is registered to attend
    - ii. 7 or 8 people have registered to attend the coaching convention
    - iii. Attendees should bring back their learnings and share with the community
      - 1. At a board meeting, during the YUC season kickoff, during coaching clinics
  - b. Ohio Ultimate Update
    - i. There has been some planning and meetings to talk about what to do with benefits USAU will be giving Ohio Ultimate
    - ii. Cincinnati Ultimate wants to be involved in any decisions related to Ultimate in Ohio
    - iii. A board must be created for Ohio Ultimate, but had not yet been created
      - 1. Liz has thrown her name in to be involved.
      - 2. CUPA will need to approve work Liz does for Ohio Ultimate
  - c. Disc Golf League Proposal
    - i. In lieu of Ultimate, Disc Golf is a safe alternative
    - ii. Want to run a league in the spring
    - iii. Will follow regular weather guidelines
    - iv. Anything we can do to keep players safely engaged is a good thing
    - v. Liz A will also be reaching out to any local disc golf organizations to partner as needed
    - vi. Should not cost much. A net neutral cost is what we are looking for.
      - 1. There will be a small fee to participate
      - 2. There will be some sort of prize for the winner (not cash)
    - vii. Nick D would like a masters division, but will not guarantee showing up every week.
    - viii. MOTION Approval to start a new disc golf league, with a net neutral cost
      - 1. Seconded by Tom Phillips
      - 2. MOTION PASSES
  - d. <u>Seven Hills Summer Camp Proposal</u>
    - i. One week camp for ages 9-12
    - ii. Great way to bring in money
    - iii. Can help us get our foot in the door of the camp groups and try out a camp model
    - iv. Could open many opportunities in the future
    - v. Need to find volunteers to help with the camp number of volunteers needed depends on how many register. Seven Hills also has a large staff of volunteers that would be there to help out
      - 1. As always, it can be hard to find volunteers. Suggestion to start looking early.
      - 2. Paying for the time of the volunteers could help. Especially since we are being paid for the camp.
    - vi. Liz A has the go ahead to continue pursuing this program
  - e. Future Tournaments
    - i. 2022 USAU events or WFDF events may happen. But absolutely nothing is concrete.
- 5. Remaining Discussion Items (8:30 8:55)
  - a. <u>Strategic Planning Process Update</u> (Ryan G)
    - i. A series of upcoming meetings is being planned to prioritize our future vision
    - ii. Meetings are open to committee members or invite only to players in Cincinnati Ultimate
  - b. COVID-19 Planning
    - i. <u>Return to Play Outline</u>
    - ii. Organizations can require vaccines (accepting doctors notes for medical exemptions)

- iii. Focus on returning to play for youth FIRST. Plan to dedicated to Youth return to play
- iv. Other organizations are looking at a 5% positivity rate
- v. Responsibilities will be placed on volunteers/coaches to help with the guidance
- vi. All coaches will be provided the same questions to ask.
- vii. What sort of ages will we be asking these questions to? For younger kids, we may want to ask for a parent/guardian to be present when asking medical questions.
- viii. How to best handle stall counts?
  - 1. No stall counts?
  - 2. Stall count from the sideline?
  - 3. Wear masks while playing?
    - a. We may experience push back from families who do other activities without masks
- ix. When do we want to return to play for adults?
  - 1. Phase 5 is indicated in the plan
  - 2. Youths stay in the same bubble (e.g. same school) where adults have a larger bubble, which is riskier
  - 3. Easier to enforce guidelines as a coach
  - 4. What about starting a league for those who are vaccinated?
    - a. 14-20 days after second shot
    - b. Depends on how vaccines are rolled out
  - 5. Do we want to require adults to have a vaccine to return to play no matter what?
- x. Want to set achievable safety standards so people are more likely to follow them.
  - 1. Provide minimum requirements, allow coaches to use stricter requirements
- xi. We want to be socially responsible and will therefore air on the side of caution
- xii. What are we looking for to get to phase one?
  - 1. If a team is associated with the school, the school needs to allow clubs to meet in person
  - 2. Must follow all state/local guidelines
    - a. State is requiring high school athletes to undergo testing before returning to play (Tom P to forward documentation to Nick D and Liz A)
  - 3. Low positivity numbers will be important to look at. 5% is a good starting point.
  - 4. Risk level tracker is a good place to look because it accounts for more than the low positivity numbers. Looking for green?
  - 5. Liz to check the percentage rate, the color, and ??? every Monday so we have history of data to watch.
    - a. Data will be recorded in a publicly available spreadsheet
  - 6. Broader than just Hamilton county, so make sure we look at all the counties.
- xiii. It would be interesting to talk to athletic directors at the schools to get another viewpoint.
- xiv. We should put together a committee of coaches to review the return to play document
- xv. CUPA can help provide discs to teams that could use more discs, wipes, masks, etc where possible
