 - i. Committees should be back up and running by August
 - b. Finance Committee (Tom P)
 - i. <u>Balance</u> / <u>Summary</u>
 - 1. Currently only spending what has to be spent
 - 2. Deposits on fields can be used for future events
 - ii. Tom P Role as Treasurer
 - 1. Tom can still be agent of record on the Hoy scholarship
 - 2. Tom cannot have any access to the money (checks/debit cards/cash flow/etc)
 - a. Does it make sense to have a treasurer who cannot access money?
 - As long as Tom cannot access the money, he should still be able to be treasurer
 - 3. **CUPA Board** should talk about having two signatures on checks in the future
 - 4. Transition to Director of Operations being more in charge of the funds, with a board member reviewing the bank statements every month
 - a. **Tom P** to train Liz A, having Tom and Liz K reviewing the work
 - b. There is a payroll processor paying the DOO salary
 - 5. Never write a check to yourself if you need to reimburse yourself
 - MOTION: Remove cash management and banking from the Treasurer (Thomas Phillips) and transition cash management and banking to DOO (Elizabeth Anderson). Treasurer role will continue to monitor bank statements.

 - b. MOTION PASSES
 - 7. **Liz A**: Password to the CUPA Paypal account MUST be changed and the connection to the CUPA bank account should be removed. A specific Business Paypal account will be created for CUPA
 - 8. **Peter Tran** to close the the CUPA Square account
 - 9. **Tom, Liz K, and Liz A** to coordinate a time to update the signatories on the account. Liz K to stay on as a signatory. Nick DiNardo to be added at a later time when it works with his schedule.
