- 3. COVID-19 Planning (7:15 7:25)
  - a. Current guidelines are to have members who have tested positive to abstain from CUPA functions for 10 days.
    - i. 10 days does feel long to those who are affected, especially for the outdoor events
    - ii. Potential to adjust the plan in the January meeting
    - iii. Should we limit it to just COVID or add additional illnesses such as the flu?
    - iv. Should we lessen the "ban" to 8 days?
- 4. Director of Operations Updates (7:25 8:00)
  - a. Financials
    - i. We need 1-2 new representatives to join the Finance committee with Liz Keuffer stepping down.
    - ii. We have gotten a CUPA credit card, that expenses have been credited to and the reward points are racking up!
      - Cashback from the rewards points will get placed back into the checking accounts
    - iii. Looking to switch banks from US Bank, Liz Keuffer will stay on administratively to help sign over the accounts a new bank before fully leaving the board
    - iv. **ACTION ITEM**: Finance Committee will review account review policies and procedures
    - v. We need to get better cash inflow to help support the salary of the Director of Operations and allow us to break even at the end of the year. For example, we need to increase league fees or host large events on a regular basis.
  - b. League Updates
    - i. Registration was a little down this year compared to other years.
    - ii. Things are going swimmingly. Winter league planning is in progress.



- iii. How can we make league signup more inclusive for those who aren't able to sign up within minutes?
  - 1. Male matching players can only sign up for 1 night of the week in Fall/Spring
  - 2. Splitting out into a beginner league in Fall/Spring to allow for more spots

      - May need to get some of the flight costs covered if the scholarship is awarded

    - 1. Current level only saves message for 90 days
    - 2. Cost is \$7.25 a month.
    - 3. ACTION ITEM: Liz Anderson to update to a paid version of Slack
